In both parishes, the goal is to maximise resources and obtain funding through the rental of available spaces, and in both, the role of Carola and Monica has proven essential.

John Diego, as Director of Operations, has been especially involved in the renovation of the Van Gogh Café, which is about to reopen, and now he has to deal with the situation of the Hall.= There are challenges, but I believe there are many more blessings. It has been a wonderful year, and I think we should congratulate ourselves.

Of course, none of this would be possible without the selfless and invaluable work of Cynthia and Carolina, on the one hand, and Simon and David, on the other, who, as Churchwardens, support the team. Alongside them is a whole host of people, from the catechists, to the PCC members, volunteers, people who donate their time and money through the red envelope and collections, and countless others who make the mission of this team possible.

7. Churchwarden Report - Speaking Spanish Congregation

This has been an eventful year for St Matthews. There is a thriving Spanish service every Sunday which attracts a large and vibrant congregation outlining the fact that clergy, leaders and volunteers keep playing an important and essential part in St Matthew's life. During 2024, we witnessed the congregation diversify, with an increase in people from Central America attending our Eucharistic service in Spanish.

The outlook for the church is reasonable and a highly efficient administrator has arranged regular lettings of church premises, manages the day to day business of the church and monitors and controls expenditure.

Ágape is still playing a very important part in the LatinAmerican community as the services have increased to the extent of being able to offer free Legal Advice to low income families, mostly of them asylum seekers. They've been also offering free English classes to those who are not able to communicate in English or need to practice and more people have become more interested in taking part in this. Christmas celebration has been playing an important part of our community every year at St Matthew's and we gratefully say thank you to all volunteers and private donors as they were the funding of this special event where 50 children from hispanic less privileged families attended getting presents, food, drinks and recreation.

A wide variety of activities and events happened during the 2024 year, leaving me gratitude and appreciation for all organisers and volunteers involved in those. Especially for the multi-cultural event celebrated at the end of August where more than 200 people gathered together at St Matthews all from different backgrounds, although mostly from South America. There was a great pleasure to see a mix of cultural diversity coming from food, dance, music, handmade products, etc.

To summarise, 2024 brought us very good times together that we can proudly say are going to last in our memories and will continue bonding us as community strengthening friendship and a sense of belonging to a community per se.

Note 1: ACCOUNTING POLICIES

The financial statements have been prepared in accordance with the Statement of Recommended Accounting Practice: Accounting and Reporting by Charities (SORP 2005), issued in March 2005 — together with the Financial Reporting Standard for Smaller Entities (effective April 2008) and Charities Act 2011.

The financial statements have been prepared under the historical cost convention. The financial statements include all transactions, assets and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their main affiliation to another body, nor those that are informal gatherings of church members.

Funds

Restricted funds represent donations/grants received for a specific object or invited by the PCC for a specific objective. The funds may only be expended on the specific objective for which they were given. Any balance remaining unspent at the end of each year must be carried forward as a balance on that fund. Unrestricted funds are general funds that can be used for PCC ordinary purposes. These include funds designated for a particular Purpose by the PCC.

Incoming resources

Planned giving, collections, donations, tax refunds, and interests are recognised when received. Grants and legacies are accounted for when the PCC is legally entitled to the amounts due. All other income is recognised when it is receivable. All income resources are accounted for gross.

Resources expended

Grants and donations are accounted for when paid over, if that award creates a binding or constructive obligation on the PCC. The diocesan parish share is accounted for when due. All other expenditure is generally recognised when it is incurred and is accounted for gross.

Fixed assets

Consecrated and benefice property is not included in the accounts in accordance with section 10 of the Charity Act 2011.

Fixed assets were stated at cost and depreciation is provided at rates calculated to write off the cost of each assets over its expected useful life, as follow: office equipment, plant & machinery and garden improvements -25% straight line method.

Individual items of equipment with a purchase price of £1000 or less are written off when the asset is acquired. No value is placed on moveable church furnishings held by the churchwardens on special trust for the PCC and which require a faculty for disposal, since the PCC considers this to be inalienable property. All expenditure during the year on consecrated and benefice buildings and moveable church furnishings, whether maintenance or improvement, is written off as expenditure in the Statement of Financial Activities and separately disclosed.
